4. FIRST AID MEASURES

If swallowed: a poison control center or doctor immediately for treatment

Ingestion: advice. Have the person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so or by a poison control center or doctor. Do not give anything by mouth to an unconscious person.

If in eyes: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, Eye Contact: if present, after 5 minutes, then continue rinsing eye. A poison control center or doctor for treatment advice.

If on skin or clothing: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-Skin Contact: 20 minutes.

If inhaled: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial Inhalation: respiration, preferably mouth-to-mouth if possible.

In Case of Fire
